In the later years, the office comprised the office of the Kenya, Uganda and Tanganyika Agent. When the three East African States became independent, the office became High Commissions for the three East African States separately. The records described here cover Kenya only.

The records of the Society, which are fairly complete, provide a wealth of source material for the study of East African history. The original records are currently housed at Birmingham University. The records include: Mission books containing copies of incoming letters; letter books containing copies of outgoing letters; journals and papers comprising of all incoming letters sent by the Mission Secretary or occasionally directly by missionaries, catechists, officials and others.
